# BRAND GUIDELINES

## LOGO: FORMATS

The following logo formats are the only way SafePass' brand should be depicted.

The Primary format should be used whenever possible.

PRIMARY | VERTICAL



The PRIMARY logo format should be used whenever possible. If the space doesn't accommodate, it is permissible to use the SECONDARY version shown below.

## LOGO: MINIMUM SIZE & CLEAR SPACE

#### SIZING



Measurement area



The minimum width of the logo is .625" when printed, or 85 pixels on screen.

Maintaining this minimum size will ensure legibility of the logotype, the width cannot be below 0.625".

#### **CLEAR SPACE**



Allow "S" cap height in all directions for empty space to let logo breathe.

Primary logo colors are: Pantone 282C Pantone Cool Gray 8C

# **COLOR: PALETTE**

Ideally, Pantone colors will be used. For print applications, it is permissible to use the CMYK equivalent. For digital applications, use either RGB or HEX.



### **TYPOGRAPHY**

The approved typography for SafePass is: Montserrat and the Avenir family.

**HEADLINES** 

#### MONTSERRAT REGULAR

Headlines should use Montserrat Regular in all caps while body copy, call outs, and secondary headlines should use Avenir font family. This font family has many weights to accommodate many functions.

The logotype cannot be altered or redrawn in any other way. Previous versions should never be used, and the logotype should not appear in a line or block of text. The word SafePass should be typed out in body copy.
